





Between national organisations of animal production for the setting up of the European Association for Animal Production (Paris, 7 November 1949)

The undersigned, representatives, duly authorised *ad hoc* by their respective national organisations for animal production,

CONSIDERING that it would be extremely useful to establish permanent and continued contacts between all those who are interested in the promotion of animal production from a technical and economic point of view,

CONSIDERING that for this reason it would be highly desirable to set up a World Federation of Animal Production,

CONSIDERING that to attain this aim it is advisable to create first associations for animal production on a continental basis,

CONSIDERING the wishes expressed for the immediate creation of an European Association for Animal Production at the 4<sup>th</sup> International Congress of Animal husbandry, Zurich 1939 and at the International Meeting on Animal Production, Zurich 1947,

CONSIDERING that the Preparatory Committee of the European Association in its meetings in Milan, June 1948 and in Paris, March 1949 has completed its work and thus laid down the foundations for the establishment of this Association.

CONSIDERING that many national organisations for animal production in Europe have approved this initiative, accepted the principles laid some in the statutes worked out by the Preparatory Committee and appointed their representatives, duly authorised *ad hoc*,

EXPRESSING their gratitude to the Food and Agriculture Organisation of the United Nations for the assistance which it has given in the preparatory work,

HAVE AGREED to proceed, signing the present document to the establishment of the European Association for Animal Production.

Signed in Paris, 7 November 1949, at UNESCO Headquarters.
